5. 收集者承諾會保留所有自送交日起計 1 年內的相關紀錄(包括但不限於令人能夠辨別就按上文第 4 段送交循環再造者的電器或電子設備的送交及接收資料),期間須隨時應銷售商要求提供紀錄作查閱或提供副本,以證明符合《產品環保責任條例》第 43(1)條的要求。

The Collector undertakes to keep all records (including but not limited to information that enables the identification of the delivery and receipt of the item(s) of electrical or electronic equipment delivered to the Recycler as mentioned in paragraph 4 above) for a period of one year from the delivery date, and to provide access to or copy of that record as required by the Seller at any time during the period as proof of compliance with the requirements under Section 43(1) of the Product Eco-responsibility Ordinance.
