- 向消費者分發受管制電器者/公司
 Means a person/company distributing REE to consumers
- 不包括只提供物流運輸服務者
 Not include transportation / logistics service providers
- 銷售商可同時是供應商
 A seller may also be a supplier

主要責任 Main responsibilities:

銷售商必須 Seller must

- 備有獲環保署批註的除舊服務方案 Have a removal service plan endorsed by EPD
- 在訂立合約前以書面通知消費者其法定除舊服務責 任及條款

Notify consumers in writing the statutory removal service obligation and terms before entering into contract

- 應消費者要求安排法定除舊服務
 Arrange statutory removal service as requested by consumers
- 提供載有中文及英文訂明字句的收據
 Provide receipt with prescribed wording in both the English and the Chinese languages to consumers
- 妥善保存一年記錄Keep records properly for one year

Ten Classes of Regulated Electrical Equipment (REE)

空調機 Air conditioners

(不超過 3 匹 Not exceeding 3 hp)

雪櫃 Refrigerators

(不超過 900 公升 Not exceeding 900 L)

洗衣機 Washing Machines

(不超過 15 公斤 Not exceeding 15 kg)

抽濕機 Dehumidifiers

(不超過 35 公升/日 Not exceeding 35 litres per day)

乾衣機 Tumble Dryers

(不超過 15 公斤 Not exceeding 15 kg)

電視機 Televisions

(不超過 100 吋 Not exceeding 100 inches)

電腦 Computers

(包括桌上、平板、 Including desktop, tablet, 手提及筆記簿電腦 laptop and notebook computer)

打印機 Printers

(不超過 30 公斤 Not exceeding 30 kg)

掃描器 Scanners

(不超過 30 公斤 Not exceeding 30 kg)

顯示器 Monitors

(不超過 100 吋 Not exceeding 100 inches)

備註 Remarks

- 抽濕機的定義:使用蒸氣壓縮循環方式操作及其額定抽濕量不超過每日 35 公升,但不包括使用乾燥劑操作的抽濕機 Definition of dehumidifiers: operate by using the vapour compression cycle with a rated dehumidifying capacity not exceeding 35 litres per day, but do not include those operate by using desiccant materials
- 乾衣機的定義:藉在滾筒內翻滾紡織品將紡織品弄乾,使用市電作唯一發熱用電源及額定乾衣量不超過 15 公斤 Definition of tumble dryers: dry textiles by tumbling in a rotating drum, use mains electricity as the only power source for heating and with a rated drying capacity not exceeding 15 kilograms
