

# 誰是供應商 Who is a supplier?



- 包括受管制電器製造商及進口商  
Include manufacturers and importers of REE
- 不包括只提供物流運輸服務者  
Not include transportation / logistics service providers
- 供應商可以同時是銷售商  
A supplier may also be a seller

## 主要責任 Main responsibilities:

### 供應商必須 Supplier must

- 經環保署登記成為登記供應商  
Be registered as registered supplier with EPD
- 呈交季度申報  
Submit quarterly returns
- 呈交審計報告  
Submit audit reports
- 繳付循環再造徵費  
Pay recycling levy
- 妥善保存五年記錄  
Keep records properly for five years

## 十類受管制電器 Ten Classes of Regulated Electrical Equipment (REE)

| 空調機<br>(不超過 3 匹)             | Air conditioners<br>Not exceeding 3 hp                                   |
| 雪櫃<br>(不超過 900 公升)           | Refrigerators<br>Not exceeding 900 L                                     |
| 洗衣機<br>(不超過 15 公斤)           | Washing Machines<br>Not exceeding 15 kg                                  |
| 抽濕機<br>(不超過 35 公升/日)         | Dehumidifiers<br>Not exceeding 35 litres per day)                        |
| 乾衣機<br>(不超過 15 公斤)           | Tumble Dryers<br>Not exceeding 15 kg)                                    |
| 電視機<br>(不超過 100 吋)           | Televisions<br>Not exceeding 100 inches)                                 |
| 電腦<br>(包括桌上、平板、<br>手提及筆記簿電腦) | Computers<br>Including desktop, tablet,<br>laptop and notebook computer) |
| 打印機<br>(不超過 30 公斤)           | Printers<br>Not exceeding 30 kg)   |
| 掃描器<br>(不超過 30 公斤)           | Scanners<br>Not exceeding 30 kg)   |
| 顯示器<br>(不超過 100 吋)           | Monitors<br>Not exceeding 100 inches)                                    |

### 備註 Remarks

- 抽濕機的定義：使用蒸氣壓縮循環方式操作及其額定抽濕量不超過每日 35 公升，但不包括使用乾燥劑操作的抽濕機  
Definition of dehumidifiers: operate by using the vapour compression cycle with a rated dehumidifying capacity not exceeding 35 litres per day, but do not include those operate by using desiccant materials
- 乾衣機的定義：藉在滾筒內翻滾紡織品將紡織品弄乾，使用市電作唯一發熱用電源及額定乾衣量不超過 15 公斤  
Definition of tumble dryers: dry textiles by tumbling in a rotating drum, use mains electricity as the only power source for heating and with a rated drying capacity not exceeding 15 kilograms

受管制電器供應商必須經環保署登記為「登記供應商」

方可分發受管制電器

A REE supplier must have been registered  
as registered supplier with EPD before distributing REE

環保署在收到已填妥申請表及所有支持文件後起計的十個工作天一般可完成登記手續

The registration process is normally completed **within 10 working days** after  
EPD's receipt of the completed application form and all necessary support documents
